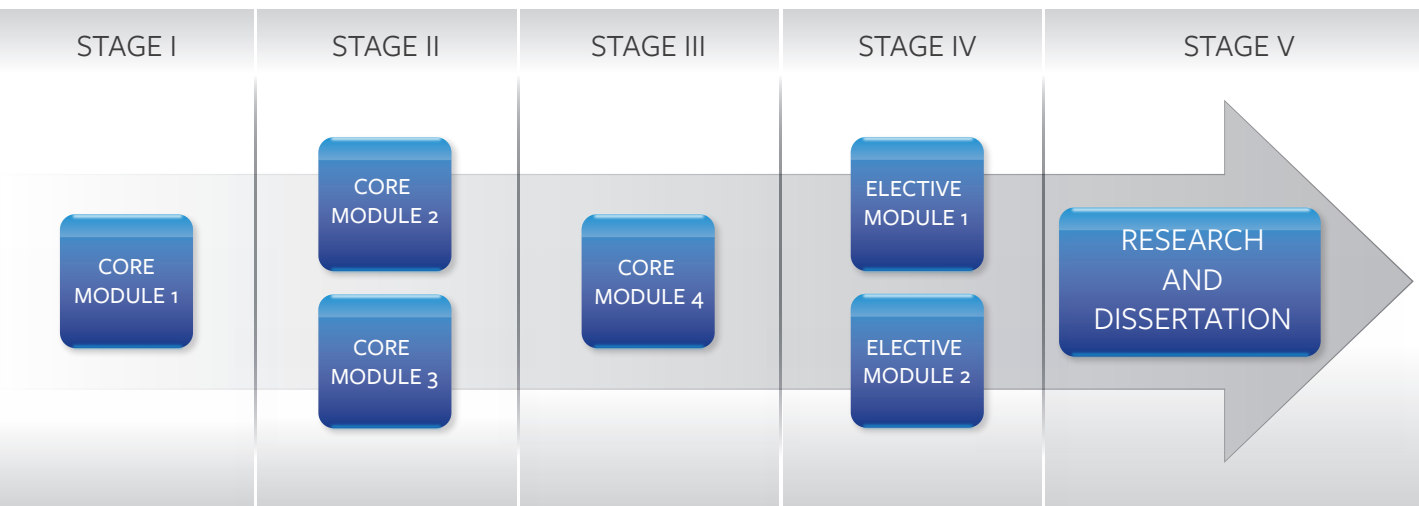

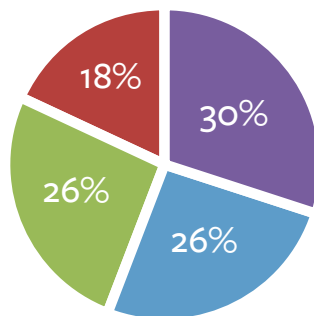

## What do I need to enrol?

### Documents

- Complete application form
- CV or résumé in English
- Copy of passport
- 2 letters of recommendation

### Qualifications

- UK undergraduate degree or equivalent
- A selection of professional qualifications will be considered for admissions
- GMAT is not an obligatory requirement but is considered an advantage.
- GMAT may be required for some full-time applications Target Score: 550

### English proficiency options

- IELTS score 6.5, (Minimum of 5.5 in each component)
- TOEFL score: 91 (minimum: L-21, R-22, S-23, W-21)
- PTE score 59 (minimum: 51 in each component)
- Cambridge Proficiency Exam (A, B) or
- Proof of equivalent level of language proficiency

### Experience

Work experience is not an obligatory requirement but is considered as an advantage. We recommend 3 years of full-time work experience prior to joining the programme.
